in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold, aliened, released, and by these presents do grant, bargain, sell and release, unto the said Thalia Bramlett Pollard, her heirs and assigns all that piece, parcel or lot of land in Fairview Township, Greenville County, State of South Carolina,

And more fully described as follows: -
Beginning at a stone near the road leading from Simpsonville to Log Shoals, and running thence N. 4 W. 31.64 crossing said road to an iron pin near the head of a branch; thence N. 67 W. 9-09 to an iron pin; thence S. 5.35 W. 9.27 to an iron pin; thence S. 77-30 W. 7.92 to a stone; thence S. 35 E. to a stone, J. R. Stone's corner; thence along Stone's line in an easterly direction to an iron pin; thence N. 29 1/2 E. to the beginning corner, and containing 10 and 13/100 acres, more or less, being the same land conveyed to me by L. A. and Mamie M. Fowler by their deed dated March 3rd 1931 and deed recorded in the office of the R. M. C. for Greenville County in Vol. 157 at Page 489.




