Briggs and Hazel M. Briggs, their heirs and assigns all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina,

And being in Ward Two (2) of the City of Greenville, on the west side of Powley Street.

Beginning at a pin on the west side of Powley Street one hundred fifty (150) feet from Park Avenue, running thence N. 25° 19' E. 50 feet with Powley Street to an iron pin (thence N. 77 W. 100 feet, more or less, to an iron pin on the E. N. Middle lot; thence S. 20° 19' W. 50 feet to an iron pin on driveway between lots of India P. Ashbury, (now deceased) and 341 N.
