

TITLE TO REAL ESTATE

KNOW ALL MEN BY THESE PRESENTS, That

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Alice Day Carroll, all my one-half undivided interest in and to all that piece, parcel or lot of land in

Southwest of the City of Greenville on what is known as the National highway, and designated as Melrose Ave. and having the following metes and bounds, to-wit:
Beginning at a point on the South side of Melrose Ave., Corner of Lot # 2, and running thence with line of Lot No. 2 and parallel with Walnut St. 131 feet to an iron pin on an alley, thence in a westerly direction, with the line of said alley 46 feet to an iron pin on the alley; thence with the line parallel to Walnut St. to an iron pin on Melrose Ave. approximately 113 feet, more or less; thence along Melrose Ave. 46 feet to the beginning and being all of lot # 11 of Block "F" of the Melrose Land Company. Plat recorded in Book "A" at page 157, except a strip of land 4 feet wide along the South side of the entire length of lot No. 11, said lot No. 11 being bounded on the North by lot No. 2, on the East by an alley and on the South by lot No. 6 and on the West by Melrose Ave. This being the same property conveyed to me and A. F. Day by Katie Goodnough by deed dated January 27, 1930, recorded in the P.M.C. Office for Greenville County in Deed Book 133 at page 253.
It is understood that this conveyance is made subject to a mortgage indebtedness in the original sum of \$5000.00 executed by the grantor herein and A. F. Day to Frank Draper but it is expressly understood that the grantee herein does not assume the payment of any portion of said indebtedness.
