Bryan C. Hood, all my right, title and interest in

*all that piece, parcel or lot of land in Township, Greenville County, State of South Carolina,
in the southeastern side of a large gully, and beginning at a point in the
center of Old State Road, and running thence northwesterly with the gully
to the property line, thence running in a southwesterly direction
following the line of adjoining owners to the beginning corner,
and being the southeastern portion of a tract of land conveyed to
J. S. Hood, Sr. by deed recorded in Vol. 166, page 549, O. M. B.
office for Greenville County, and known as the John S. Hood, Sr.,
Homestead.*

*Also, all that certain parcel and lot of land north of the City of
Greenville, on what is known as Park Place, in Block C and a portion
of Lot no. 2 having a frontage of fifty feet on First Avenue, now New
Buncombe Road, by a uniform width to a depth of one hundred feet
