All that certain piece parcel or lot of land just outside the
City of Greenville in Greenville County, State of South Carolina, being known
and designated as lot no 53 as shown in plat of the property of Wm.
Hobbs recorded in the U. S. Office for Greenville County in Plat Book
vol. 1st page 111 and having, according to said plat, the following
natural and locational corners and dimensions, to wit:

Begins on an iron post on the North side of Gilligan
Avenue, which runs from the Northwestern corner
of the intersection of Gilligan Avenue and McDonald Street,
the front corner of lots nos 53 and 54; thence running with
the front line of said lots N. 18° 17' E. 170 feet to an iron post
on the South side of a 10 foot alley, thence along the
center of said alley N. 71° 43' 34.77 feet to an iron post, thence
N. 13° 47' 28.170 feet to an iron post on the north side of
Gilligan Avenue, thence along the line of said Avenue
a 16.43.7 feet to the point of beginning.
