

TITLE TO REAL ESTATE

KNOW ALL MEN BY THESE PRESENTS, That I, J. T. Putnam of Greenville City and County,

In the State aforesaid,

in consideration of the sum of Fifteen hundredDollars,to me paid by B. E. Griffin.In the State aforesaid, the parties whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said B. E. Griffin and his heirs and assigns,

In the Township of Greenville, Greenville County, State of South Carolina,

All that certain piece of land and lot of land lying and being situated in the City of Greenville, County and State aforesaid over Frank and Francis Streets, and more specifically described as follows: Beginning at a corner pin at the property line on the North side of Francis Street and the East side of Nova Street and running thence along Nova Street N 15° W 68 feet, more or less, thence North 88° 53' feet, more or less, to the Eastern boundary of the property last before conveyed to me by Anna Thompson, thence along the line of that property in a generally easterly direction 70 feet, more or less to Francis Street, thence along Francis Street 112 feet, more or less to the beginning corner, and being a portion of the land conveyed to me by Anna Thompson by her deed dated Oct 26, 1925 and recorded in the office of the R. H. C. for Greenville County in book 96, page 71. It is distinctly understood and agreed that this conveyance is to include all of the property lying North of Francis Street and between the two in question, a distance of about one-half mile. The dimensions given are approximate.

The above described land is the same conveyed to me by Anna Thompson on the 10th day of January, A.D. 1925, deed recorded in office of Register of Deeds Conveyance for Greenville County, in book 96, page 71.

TOGETHER with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the said B. E. Griffin and his heirs and assigns forever.

AND I, J. T. Putnam, do hereby bind myself and my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said B. E. Griffin and his heirs and assigns, against all and every person whomsoever lawfully claiming, or to claim, the same, or any part thereof.
