

TITLE TO REAL ESTATE

in the City of Greenville on the southwest corner of Robinson and Craft Streets,

known and designated as Lot No. 7 on Plat of Green Heights.

Beginning at an iron pin at the southwest corner of Robinson and Craft Streets and running thence with Craft St. N. 85.35 W. 100 feet to iron pin; thence S. 1.50 W. 50 feet to an iron pin; thence S. 85.35 E. 100 feet to an iron pin on Robinson Street; thence with it, N. 1.50 E. 50 feet to the beginning corner, being the same lot conveyed to me by J.
