all that place, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina,
on the east side of Jones Avenue and known and designated as Lot No. 19, of W. C. McDaniels property according to a Plat of said property recorded in the R. M. C. Office
for Greenville County in Plat Book F, page 186, and having the following metes and bounds
to-wit:

Beginning at an iron pin on the east side of Jones Avenue, at the corner of Hatch property, and running thence with line of said property S. 89 E. 171.2 feet to an iron pin, corner of lot No. 20; thence with the rear line of lot No. 20, N. 5-08 E. 70.8 feet to corner of lots Nos. 18 and 21; thence with the line of lot No. 18 N. 89-13 E. 174.7 feet to pin on Jones Avenue; thence S. 1 W. 70 feet to the beginning, being the same conveyed to me by W. C. McDaniels by deed dated April 7, 1928, and recorded in Deed Book 136, page 213, R. M. C. office for Greenville County.

It is understood and agreed that this lot is conveyed subject to the following conditions:

1. That no building shall be erected on said lot so that any part of said building will be nearer than 30 feet of the property side-walk line.
2. That said lot shall not be sold or rented or otherwise disposed of to any person or persons of African descent.

As a part of the consideration the Grantee herein assumes and hereby agrees to pay the balance of \$2640.00 on a mortgage heretofore given by Mattie Pearl Chiles to South Carolina Security Company and assigned to the Metropolitan Life Insurance Company, which mortgage is recorded in Vol. 230, page 46, R. M. C. Office for Greenville County. Said mortgage was originally given for \$3000.00, and there is a balance due on same of \$2640.00 at the time of the delivery of this deed.

The above described land is the same conveyed to me by on the day of 10, deed recorded in office of Register of Mesne Conveyance for Greenville County, in Book , Page.

TOGETHER with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the said J. A. McMahan, his
