TITLE TO REAL ESTATE

Dollars,

to me *just to Lizzie McDowell of Simpsonville*in the State aforesaid, the sum whereof is hereby acknowledged, here granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said *Lizzie McDowell*

Township, Greenville County, State of South Carolina,

A certain lot or tract of land lying in town of Simpsonville, County and State aforesaid. It called on old name Dormitory of colored School building and containing lands of late Mr. C. L. Clegg with said Estate of H. J. Wilson and having the following notes and boundaries - Beginning at an iron post in corner of Woodsome corner one 20 ft. alley and running thence along the line of same. Extending direction 160 feet to another iron post. thence to the northward bearing 100 feet to another post in said alley. thence in a southward bearing direction along said alley 55 feet to the beginning corner containing about 8800 sq. ft. more or less. This being said lot is described to me by Mary McDowell as aforesaid. First day of May number 1922 it is recorded. Date 75 August 77.
