

DEED TO REAL ESTATE

STATE OF SOUTH CAROLINA,

KNOW ALL MEN BY THESE PRESENTS, That I, Estelle Parham, of Greenville

in the State aforesaid in consideration of the sum of One hundred and no/100 Dollars,

to and paid by Ella Francis

in the State aforesaid, the county whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ella Francis, Chick Springs, Township, Greenville County, State of South Carolina,

all that piece, parcel or lot of land in on the Furman Hall road, and being a portion of Tract No. 4, of the property of J. C. Hall, as shown on plat thereof made by R. E. Dalton, Dec. 1916, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the east side of Furman Hall Road, at a point 314 feet from the intersection of Furman Hall road with the Chick Springs road, and running thence along the line of said Furman Hall road, S. 28-15 W. 125 feet to an iron pin, corner of lot of E. B. Poister; thence along the line of said E. B. Poister, S. 53-40 E. 300 feet to an iron pin; thence N. 23-15 E. 121 feet to an iron pin, rear corner of lot of Estelle Parham, thence along the line of said lot N. 58-40 W. 300 feet to an iron pin on Furman Hall road, the beginning corner. It being the intention of this deed to convey my undivided one-half interest in the above described lot. This being a portion of the property conveyed to Ella Francis and Estelle Parham by Henry D. McGee by deed dated July 7, 1934 and recorded in the R. W. C. Office for Greenville County in Vol. 176, page 109."

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the said Ella Francis and her heirs and assigns forever

AND I do hereby bind myself, my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said Ella Francis, and her heirs and assigns, against myself and my heirs, and every other person whomsoever lawfully claiming, or to claim, the same, or any part thereof.
