In the State aforesaid, the parties whereof have agreed, bargained, sold and released, and by these presents do grant, bargain, sell and
convey unto the said Grace C. Whatley, her heirs and assigns, a one-half undivided interest in and to
all that piece, parcel or lot of land in

Austin

Township, Greenville County, State of South Carolina,

in the Town of Mauldin, on the west side of the main highway leading from Greenville, to
Laurens, having the following mates and bounds, to-wit:

Beginning at a corner of Coke White land, on the west side of said highway, and running thence S. 76-30 W. 21.80 chains along Coke White's line to an iron pin, corner of said Coke White's line; thence with the rear line of this tract and Coke White's line S. 12-35 E. 19.10 to an iron pin, new corner on tract that goes to James F. Whatley; thence N. 64-30 E. 23.10 to the Laurens Road; thence with said highway northerly 14.04 to the beginning corner, according to a survey made by C. L. Furman, August, 1934, dividing lands of R. A. Whatley, deceased.

This is the same land conveyed to me, said J. P. Whatley, by James F. Whatley, et al.
the heirs at law of P. A. Whatley, deceased, deed dated September 8, 1934, to be recorded.
