Beginning at an iron pin on the Spartanburg Road 61 feet Southeast intersection

to an iron pin; thence S. 52-40 W. 60.9 feet to an iron pin; thence N. 37-20 W. 186.4  
feet to an iron pin on the Spartanburg Road; thence along said Spartanburg Road N. 58-00
