in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ray Waters, his heirs and assigns

all that piece, parcel or lot of land in Waccamilla Township, Greenville County, State of South Carolina,

Near the City of Greenville, known and designated as lot No. 99 of the subdivision known as Augusta tract, as shown on a plat of record in the P.M.O. Office of Greenville County, South Carolina, in Old Book 2, at Page 23, and having according to said plat the following metes and bounds, to wit:

Beginning at an iron pin on the Eastern side of Jarvis Road, joint corner of lots Nos 98 and 99, and running thence with the joint line of said lots S. 71. 35 E. 160.7 feet to an iron pin, joint corner of lots Nos 84, 85, 98 and 99; thence with the joint line of 84 and 98 S. 21. 35 W. fifty feet to an iron pin, the joint corner of lots Nos 83, 84, 99 and 100; thence with the joint lines of lots 99 and 100 N. 71. 35 W. 156.3 feet to an iron pin on Jarvis Road; thence with the eastern side of Jarvis Road N. 16. 30 E. 49.96 feet to the beginning corner, and being the same lot of land conveyed to me by W.
