being in Ward Four of the City of Greenville and having the following notes and bounds:

to-wit: Beginning at an iron pin on the South side of Lewis Street 180 feet from the intersection of Lewis Street and Oakland Avenue, joint corner lots Nos. 21 and 23, and running thence with line of lot No. 22, S. 34-50 W. 150 feet to an iron pin; thence N. 62-19 W. 60 feet to an iron pin, joint rear corner lots Nos. 21 and 20; thence with line of lot 20, N. 34-50 E. 150 feet to an iron pin on Lewis Street; thence with Lewis Street, S. 62-19 W. 60 feet to the point of beginning.
