

## LEASE

THE STATE OF SOUTH CAROLINA,  
County of Greenville.

W. H. Bellotck

lessor,

H. J. Hellaway

lessee,

for the following use, viz.: Business premises

the

Property situated at Greenville  
for the term of One (1) year beginning this day, to wit, April 12, 1946

and the said lessee

in consideration of the use of said premises for the said term, promises to pay the said lessor the sum of Twenty-five dollars  
(25.00)

per month payable on the first of each month

The lessee hereby agrees to take the building just as it stands unless otherwise agreed upon in writing, and the lessee only require of the lessor the use of the premises for the business mentioned but no other. The lessor to repair the roof should it leak, it is also fully agreed that the roof is considered sound and the lessor not to pay any damages from hauls should any occur. Use of the premises for any business other than herein called for shall cancel this lease if the lessor so desires and give notice of same in writing.

If the business is discontinued or the premises vacated before the expiration of the lease then the whole of the unexpired time becomes immediately due and payable.

Outside signs to be erected that may connect with the gables or any other outside part of the building must be consented to by the lessor before being erected.

If the property is damaged or destroyed by fire or lightning, the lessor will repair the damage and the lessee will pay all expenses.  
That the lessor will repair the roof if it leaks and the lessee will pay all expenses.  
That the lessor will repair the windows if they break and the lessee will pay all expenses.

To have and to hold the said premises unto the said lessee, his executors and administrators for the said term. It is agreed by the parties hereto that this lease shall continue from year to year on the same terms, unless the party desiring to terminate it after the expiration of the term above mentioned give to the other party Three (3) months written notice previous to the time of the desired termination, but the destruction of the premises by fire or making it unfit for occupancy or other casualty, or one hundred months arrear of rent, shall terminate this lease, at the lessor's option. The lessee agree to make good all breakage of glass and all other injuries done to the premises during the term, except such as are produced by natural decay and agree to make no repairs, improvements or alterations in the premises without the written consent of the lessor nor sub-lease without the lessor's written consent.

The lessee hereby acknowledges having a duplicate of this lease.
