in hand paid
at and before the sealing of these presents by *Charles L. Hart, Hattie Hauff*.

(The party whereto is hereby acknowledged, has Committed, Purchased, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Charles L. Hart, Hattie Hauff, his heirs and assigns,
 and that he may, parcels or part of land in
 the Township, Greenville County, State of South Carolina
 in County Park, containing 10.39 acres, more or less, and
 hereafter known as lot of J. Shultz Stewart as lot No. 2, and
 having according to said plat the following lines
 and boundaries, to wit,

Begins at a Tree on the River, thence up the
 River to a Stake on the line of lot No. 3, thence N. 77 W.
 1.88 ft. to a Oak tree, thence S. 88 1/2 E. 34.86 ft. to a Pine, thence S.
 68 1/2 E. 4.70 ft. to corner of tract No. 4, thence S. 68 1/2 E. 51.8;
 thence S. 15.62 E. to the line of tract No. 1, thence S. 74 1/2 E.
 9.28; thence S. 9.22 E. 10.62 ft. a stone, thence S. 64 E. 12.42
 to the beginning.

This is the same tract of land conveyed to me by
 deed of J. P. Stewart Master, dated January 4, 1803, and
 recorded in the R. M. L. Office for Greenville County in
 Volume 18, page 274, and the lower interest
 therein was conveyed to me by deed recorded in
 Volume 19, page 30, in the R. M. L. Office for
 Greenville County, S. C.

This deed is an absolute conveyance of title in
 effect as well as in form, and is not intended as
 a mortgage, trust, conveyance, or security of any kind.
 The consideration therefor is the full release of all
 debts, obligations, costs and charges heretofore subsisting
 or descended by and by the terms of that certain
 mortgage heretofore existing on the property herein
 conveyed, which mortgage was executed by G. A. Hauff
 to Hattie Hart, Hattie for \$1,000.00, and recorded in
 the R. M. L. Office for Greenville County in Mortgages
 Volume 24, at page 10, and the note secured thereby,
 this conveyance completely satisfying said obligation
 and terminating said mortgage and note and any
 effect thereof in all respects.
