All those three certain lots or parcels of land, situate, lying and being in Greenville Township, County and State aforesaid, known as Greer Park and being better known and designated as lots Nos. 231, 234 and 235, which lots are on a plat made by R. C. Dalton, C. E., March 17, 1923, which plat is duly recorded in the R. M. G. Office for Greenville County, said lot having, according to the aforesaid plat, the following miles and bounds, to wit:

Lot No. 231, Beginning at an iron pin in the Northern side of Byrd Boulevard, corner of lots Nos. 231 and 232, and running thence southwardly 100 feet to an iron pin in line of lot No. 232, thence with line of that lot N. 44-47 E. 105 ft. to an iron pin in line of lot No. 233, thence southwardly 100 feet to an iron pin in line of lot No. 233 N. 44-47 E. 186.6 ft. to an iron pin on Byrd Boulevard, thence with said Byrd Boulevard S. 00-28 E. 150 ft. to the point of beginning.

Lot No. 234, Beginning at an iron pin, the northwester corner of Byrd Boulevard and an unnamed street, thence along Byrd Boulevard N. 05-15 E. 100 ft. to an iron pin corner of lot No. 233, thence with line of that lot N. 24-32 E. 210.3 ft. to an iron pin in line of lot No. 235, thence with line of that lot S. 44-47 E. 105 ft. to an iron pin on the unnamed street, thence along the west side of said unnamed street in a southerly direction 165.1 ft. to the point of beginning.

Lot No. 235, Beginning at an iron pin on an unnamed street, point corner of lots Nos. 234 and 232 and running thence with said unnamed street N. 05-15 E. 100 ft. to an iron pin corner of lot No. 234, thence with line of that lot N. 24-32 E. 100 ft. to an iron pin corner of lot No. 235, thence S. 63-34 E. 160 ft. to an iron pin in line of lot No. 234, thence S. 44-47 E. 269.9 ft. to the point of beginning.

Also, all those two certain lots or parcels of land situate, lying and being in Greenville Township, County and State aforesaid, in a subdivision known as Greer Park and being better known and designated as lots Nos. 230, 232 and 233, which lie on the Northeastern side of Byrd Boulevard and have the following miles and bounds according to a plat made by R. C. Dalton which plat is recorded in the R. M. G. Office for Greenville County, the same:

Beginning at an iron pin on the Northeastern side of Byrd Boulevard joint corner of lots Nos. 233 and 234 and running thence with the joint line of said lots N. 24-32 E. 210.4 ft. to an iron pin in line of lot 233, thence with the line of that lot N. 44-47 E. 105.1 ft. to an iron pin in line of lot 231, thence with line of that lot N. 24-32 E. 254.1 ft. to an iron pin on Byrd Boulevard, thence with said Boulevard S. 00-28 E. 150 ft. to the point of beginning.
