All that certain piece parcel or tract of land situate lying and being in Highland Tp. and County of Greenville and State of S.C. containing 18.8 acres more or less and known and designated as tract #3 as shown by a survey and plat of the estate of H. L. Campbell made by H. E. Dalton Esqr. Oct. 1901 and having the following notes and courses and distances: Beginning at a pin on Beaverdam located at corner of lands of H. L. Campbell and running thence S. 14.10.31.943 feet to a stone on branch, thence S. 84.90 E. 192 feet, thence S. 50.35 E. 187 feet to a stone, thence along line of lands of H. L. Campbell S. 23.20 W. 647 feet to a stone, thence N. 70.5.5. along the line of the Home property 910 ft. to stone, at Ford on Beaverdam thence N. thence along the meander of said creek as the line to the beginning corner.

Also all that piece parcel or tract of land lying and being in Highland Township and State aforesaid: Beginning on stone north of the Tugelo road near on corner of H. L. Campbell and J. S. Crain thence running near creek with J. S. Crain's line to a stone, thence south to a stone, thence east to a stone corner of school land, thence N. E. with school land to stone on road leading to H. L. Campbell's residence, thence near N. E. with school land to stone on the south side of Tugelo road, thence N. W. to beginning corner a stone, and containing 10 acres more or less.

Also all that certain piece or parcel of land situate situate lying and being in Highland Tp. and County aforesaid Beginning on a stone the corner of H. L. Campbell, thence near north to a stone, thence near S. W. to iron pin on the bank of Beaverdam creek, thence down and with meandering of Beaver Dam creek to paper on bank of said creek, thence near N. E. to a stone the beginning corner and containing seven and one half acres more or less.

Also all that tract or parcel of land beginning at a stone on the south side of Tugelo road, thence southeast to a stone, thence southwest to school and H. L. Campbell's line to a stone, thence northwest to a stone at the school house corner, and thence north east to beginning corner a stone on south side of Tugelo road, and containing one half acre more or less.
