A. L. E. Pickel, her heirs and assigns  
 All my one half interest in and to all that piece  
 of land located in Greenville Township, Greenville  
 County, State of South Carolina, about one acre or  
 half a mile south of the Greenville Court House, con-  
 taining 38.6 acres, more or less, and having the fol-  
 lowing notes and bounds, to wit:

Beguning at a corner (small bridge) on the  
 Fork Shoals Road, and running thence S. 48 E.  
 5.00 chains to stone 34, thence S. 41 E. 2.90 to stone,  
 thence S. 58 E. 5.19 to stone, thence S. 23 E. 4.10 to  
 stone, thence S. 62 W. 2.45 to poplar 34, thence N. 38 E. 26  
 f. 44 to iron gun in road, thence S. 12 E. with roads  
 31.75 to stone, thence S. 81 E. 9.78 to stone (old mark)  
 thence N. 23 E. 21.16 to stone, thence N. 60 E. 30.70 to  
 stone on Fork Shoals Road, thence N. 34 E. up road 11.65  
 to the beginning corner ad joining lands now or formerly  
 of J. J. Ashurst, H. H. Scott, J. G. Colbds and J. B. Alexander.

Also, all my one half interest in and to all  
 that other tract of land in the State and County  
 aforesaid adjoining the tract above described and  
 containing 18.04 acres more or less, and having  
 the following notes and bounds:

Beguning on a stone 340 m. in road leading  
 from the Fork Shoals Road to the old Harris Homestead,  
 thence S. 11 E. 27.9.00 to stone 340 m., thence S. 38 E.  
 11.44 to poplar on branch, thence N. 62 E. 2.42 to stone 340 m.  
 thence N. 23 E. 4.10 to stone 340 m., thence N. 58 E. 5.19 to  
 stone on bank of ditch 340 m., thence N. 41 E. 2.90 to stone  
 in ditch 340 m., thence up ditch N. 18 E. 5.00 to corner  
 in center of the Fork Shoals Road, in center of a  
 small bridge 340 m., thence up Fork Shoals Road to  
 33.26.6.10 to a corner in Fork of said road and the road  
 leading to the old Harris Homestead, thence up the  
 center of the old Harris House road 12.14 to the begin-  
 ning corner, and adjoining lands of Roberts and  
 others.
