 tance of 138 feet, 8 inches from the Southeast corner of Rutherford Street  
 and Randall Street and running thence S. 85-39 E. 200 feet to a stake,  
 thence S. 1-41 W. 67 feet, 8 inches to a stake, thence N. 85-39 W. 200 feet  
 to a stake on Rutherford Street; thence with Rutherford Street "N.  
 1-41 E. 67 feet, 8 inches to the beginning corner.
