Arthur Miller, all that piece, parcel or tract of land situate, lying and being in the State aforesaid, aforesaid in Rock Mountain Township, about three miles from the City of Greenville, known and designated as part of tract No. 1 on a plat made by William D. Nease, dated January 7th, 1919, and recorded in the office of R.M.C. for Greenville County in Plat Book 6, at Page 120.

said tract has the following metes and bounds, to wit:—Beginning at a stone on the east side of the road leading from the Rutherfordton road to the old Alex Linton Stock Farm (now the New Barncombe Road), the same being the corner of H. J. Watson land and runs thence along the line of Watson, Green and Heyneworth N. 53-15 E. Nineteen hundred and sixty-eight feet (1968) to a stone on line of Tract No. 3 of Peat, thence along line of said tract N. 80-15 W. three hundred and forty-three feet (343) to a stone near corner on said line and the dividing corner between Land and Miller Land; thence S. 43-15 W. one hundred and twenty feet (1720) to an iron pin on east side of road aforesaid; thence S. 33 E. Two hundred and Eighty-four feet (284) to the beginning corner and contains twelve acres, more or less and is the same tract of land deeded by B. P. Miller to D. L. Land by deed dated March 31, 1921, and recorded in Volume 62, at Page 44.
