Beginning at a stone 34 on north bank of branch and running north 50 east 2.50 chains to a stone, thence south 65 deg. East 2.00 chains to a stone 34, thence north 25 east 10 chains to a stone, thence north 32 $\frac{1}{2}$  west 21.50 chains to a stone 34, thence south 37 west 5.50 chains to a stone 34; thence north 65 west 2.00 chains to a bleak hornet, thence south 12 west 37 chains to a stone 34 on the bank of the above named branch; thence down the branch with its meanderings to the Beginning corner containing one hundred and two acres more or less.
