Rosa French, the following property to-wit;  
 All that piece parcel or lot of land in  
 Greenville Township, County and State aforesaid,  
 known as Lot No. 51 of Pride & Patton Land Company  
 on plat of said Corporation made by P. E. Dalton,  
 Engineer and recorded in office of R. M. C.  
 for Greenville County, in plat book "C", page 249,  
 said lot having the frontage of 50 feet on the  
 north side of Heatherly Drive, with a depth along  
 its eastern side of 197.4 feet and along its  
 western side of 197.4 feet and being 60.94 feet at  
 rear and being the same lot of land conveyed  
 to Messrs. Puerto and Schrader by Pride and  
 Patton Land Company by deed dated February

 thence S. 53-45 E. 58 feet to iron pin, thence S.
