

All those three certain pieces, parcels or lots of land situate lying and being on the North side of West Washington Street, in Ward One of the City of Greenville, State of South Carolina, and being known and designated as Lots numbers 10, 11 and 12 on a plat of property of J. Westervelt; thence with said line S. 21-49 W. 80 feet to an iron pin on the North side of West Washington St.; thence with said street as the line S. 68-06 E. 60 feet and one-half inch to the beginning corner, being the same lot of land conveyed to A. C. Walker by J. I. Westervelt by deed dated January 20, 1925, recorded in the R. M. C. Office for Greenville Co. in Vol. 103, Page 41.
