All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, in the sub-division of the property known as "East Park" shown on plat made by W. A. Adams July 1909, and recorded in Plat Book A, Page 383; Beginning at iron pin 140 feet from Ebaugh Avenue at the corner of lot now owned by W. H. Dempsey, and running thence with line approximately 118 feet 2 inches to a stake on the Laurens Road; thence with the Laurens Road 50 feet in a northwesterly direction to a stake; thence in a southwesterly direction approximately 114 feet 2 inches to a stake which is 140 feet from Ebaugh Avenue; thence in a southeasterly direction parallel with Ebaugh Avenue 50 feet to the beginning corner. Being the same property deeded to L. M. Templeton by W. H. Dempsey, as shown by deed recorded in the office of R. M. C. Cor Greenville County in Vol. 37, Page 162.
