Miller Mill, a corporation of South Carolina

All that lot of land in the City of Greenville on the East side of Sullivan Alley, having the following course and distances according to survey and plat by R. E. Dalton, Engineer, November 17th, 1934. Beginning at an iron pipe on East side of Sullivan Alley and running thence S. 18-48 24. 8 89.5 feet to iron pipe; thence N. 30-34. E. 96 feet to iron pipe, corner lot this day conveyed by grantee to grantor; thence N. 80-30 24. 25.7 feet to beginning corner, said lot being triangular in shape and being a portion of lot of land conveyed to grantor by Ed Inman Master, by Deed dated recorded in R.
