Locke,

All that piece, parcel, or lot of land, known and designated as Lot Nos. 80 and 82 of a subdivision known as Washington Heights and having according to a plat thereof made by C. M. Farnam Jr., Engineer February 3, 1923, and recorded in P. M. Office for Beechville County in Plat Book 5, at page 4 of the following metes and bounds, courses and distances, to wit:

Lot No. 80 Beginning at an iron pipe on the South side of Lincoln Street at the intersection of 6. + G. RR right of way with said street and running thence along the South side of said street N. 43-35-20. 53 feet to an iron pipe, thence S. 46-35-20. 00 feet to an iron pipe, thence S. 43-35-20. 53 feet to an iron pipe to the right of way of 6. + G. RR Railroad Co.; thence along said right of way in a northeasterly direction to the point of beginning on Lincoln Street. Lot No. 82, Beginning at a point on the Northern side of Lincoln Street, joint southwest corner of Lots #81 and 83 and being 31. 75 feet from the intersection of Lincoln Street with the edge of the 6. + G.
