Know all men by these presents: That the undersigned, of said County and Shate, hereinefter called Granter, for and in consideration of the terms, conditions and privileges hereinafter expressed, and the sum of one (31.00) Dollar to the Grantor in hand paid by Parker Water and Sewer Sub-District, of Greenville, South Carolina, the receipt whereof is hereby acknowledged, do hereby grant unto the said Grantee, its successors and assigns, the right, privilege and occessent to go in and upon that tract or lot of land situate in Greenville Township, in said County and State, and described as follows: Lot = 58 of Suledivision. Amount and the New iseast mean the Paris mountain Road, and the New Burner would near the Paris mountain Road and the New Burner War combe Road about 3 1/2 miles from the Eity of Greenville Plat of 22me recorded in I lat Book "2" at parit 199.

and to construct, maintain in and upon and use in and through said premises. in a proper manner, with mecessary apparatus and applicates such as machinery, air vents, manholes, blow-off connections and any and every other necessary and proper attachment nice lines, for water and sewerage purposes turough the premises above described, together with the right at all times to enter in and upon said premises for the purpose of inspecting and making mecessary repairs and alterations of said line, together with the right to cut away and keep clear of said lines all brees and other obstruction that may in any way endanger the propor operations of same.

It is Understood and agreed: That the essement herein granted shall extend throughout the property of the Grantor about 50 feet, and stall be of such width as the Grantes shall deem necessary for the purposes herein specified, and that the damage for which said Grantee may be held liable shall be confined to that arising from the use of this strip only, and nothing beyond.

It is further agreed and understood; "bat this easement is to be used only during the construction or repair of said pipe lines and with the exception of the right of the Grantee, its successors and assigns, agents, servents, and employees to inspect said pipe lines and to enter at any point and make repairs, the Grantor has the right to cultivate and use the land; provided, however, that this shall not apply to such part wherein the top of the pipe is less than eighteen (18) inches under ground.

It is further agreed; that, as a part of the occalideration hereof, the Grantor herein and the heirs and assigns of the same, may make taps or connections with said pipe lines bearing the expense thereof, provided, however, that such connections or taps by made only under the rules and supervision of the engineers representing the Grantes, its successors and assigns.

It is further understood and agreed: That in case of future damage to arops or property due from accident in said pipe lines, the Grantee shall pay reasonable damage therefor.

The payment and privileges above specified are hereby accepted in full server ment of all claims and damages for said easement.

All other terms and conditions of this Grant of Essement are as follows:
