MILNESSETH:

That, for and in consideration of the sum of Ten Dollars (310.00) and of other valuable considerations paid by the party of the second part to the party of the first part, the receipt whereof is hereby acknowledged; the execution and deliver by the said party of the second part of a principal note in the sum of \$3465.00 secured by a first deed of trust or mortgage on the premises hereinafter described, bearing even date herewith and to be simultaneously executed and delivered; the assumption by him of the taxes and assessments, assessed or assessable upon the premises, for the year of 1934 and all installments of assessments whenscever assessed, tayable during and subsequent to the said year of 1934, and other good and valuable considerations, the receipt of which is hereby acknowledged, the said party of the first part toth hereby give, grant, bargain, sell and convey unto the said party of the second part, his meirs and assigns, the following described property:

All that certain piece, parcel or lot of land situate, lying and being in the State of Could Carolina, county or Greenville, just without the corporate limits of the City of Greenville, being known and designated on a plat of the O. P. Mills property as Lot No. 8, in Block K, said plat being recorded in the R.M. C. Office for Greenville County, in Plat Book F. page 171, and naving, according to a survey made July, 1936, by Dalton & Neves, the following metes and bounds, to-wit:-

Beginning at a point on the South side of Prentiss Avenue, which point is 498 feet West from the intersection of Aission Street and Prentiss Avenue, and running thence S. 44-33 E. 180 feet to a point; thence S. 45-27 W. 62 feet to a point; thence N. 44-33 W. 180 feet to a point on the South side of Prentiss Avenue; thence along said Prentiss Avenue N. 45-27 E. 62 feet to the point of beginning.
