

upon condition that the same be maintained in perpetuity in good condition at a public street, and if the same be abandoned at any time hereafter or not kept in good condition, the title thereto shall revert to said grantor or its successors or assigns; and in the event of the dissolution of said grantor prior to the happening of such event, and leaving no successor, then the title to said property shall vest in the owners of such portions of the property now belonging to said grantor as may abut immediately upon such street; the true intent hereby being that the ten foot strip last hereinabove described shall, together with an adjoining strip immediately east thereof, granted to said City by other property owners, constitute a public street connecting the East end of said Russell Avenue, with Craft Street and the extension of Craft Street.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
