All that lot of land situated on the North side of Hillcrest Drive, in Greenville County, State of South Carolina, having the following Metes and bounds, to-wit:

Beginning at a pin on the North side of Hillcrest Drive at a point 100 feet East of the northeast intersection of North Main Street and Hillcrest Drive, and running thence with Hillcrest Drive S. 66-30 E. 90 feet; thence N. 23-30 E. 190 feet; thence N. 66-30 W. 29 feet to intersection the rear line of lot #3, owned by C. O. Milford; thence with the line of lot #3 S. 14-47 W. a distance of approximately 2 feet to the joint rear corner of lots #2 and #5; thence along the joint line of these lots N. 66-30 W. approximately 61 feet to a joint corner with a triangular strip of land now owned by Lucy L.
