Smith, All that certain piece parcel or lot of land, situate, lying and being in Greenville County, State of South Carolina Chick Springs Township and within the incorporate limits of the town of Greenville and being more particularly described as follows: Beginning at an Iron Pin on the southeast corner of the intersection of Cannon Street and Arlington Avenue and running thence with Arlington Ave. S 83-15 E 121 feet to an Iron Pin at the intersection of Arlington Avenue and Line Street; thence with Line Street S 3 W 204 feet to an Iron Pin corner of lot 5; thence with Line of lot 5 in a westerly direction 101 feet to an Iron Pin on line of lot 3; thence with line of lot 3 in a northeasterly direction 82 feet to an iron pin, joint corner of lots 1, 2, 3 and 4; thence in a westerly direction with the northern line of lot 3 90.5 feet to an iron pin on Cannon Street; thence with Cannon Street N 31 E 120 feet to the beginning corner.
