 unto the said Charlotte A. Rigby, all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina,  
 on the North side of Perry Avenue, being Lot No. 63 of the property formerly owned by Odie Ishman and H. J. Haynesworth, known as Hinglins  
 Heights;

Beginning at a stake XXX on the corner of B. L. Hughee lot  
 and thence running S. 67 1/2 E. 50 feet with Perry Avenue to a stake;  
 thence along line of Lot No. 63, 192 feet to stake on a street; thence  
 with said street N. 67 1/2 W. 50 feet to corner of said Hughee lot; thence  
 with his line 192 feet to the beginning corner. Being the same lot of land
