I, E. INMAN, Master in and for the County aforesaid, SEND GREETINGS:

WHEREAS, Claudia K. Jones

on or about the 26th day of September in the year of our Lord nineteen hundred and thirty-three, exhibited her complaint in the Court of Common Pleas, for the County aforesaid, against Jennie Lee McCullough, William Rickett McCullough, et al

demanding judgment in relation to the real estate hereinafter mentioned and described; and the cause being at issue, came on to be heard on the 17th day of May, 1927, and such proceedings were had therein as resulted in a Decree

of the said Court, wh. reby it was adjudged and decreed that the said real estate hereinafter mentioned and described be sold by E. NOW, THEREFORE, Know All Men by These Presents, That I, E. INMAN, Master in and for the County of Greenville, aforesaid, in consideration of the sum of One hundred and no/100 (\$100.00) Dollars, to me paid by the said J. E. Howell and M. H. Lynn,

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold, and released, and by these Presents DO GRANT, bargain, sell and release unto the said J. E. Howell and M. H. Lynn,

"All that certain lot of land in Greenville County, Greenville Township, South Carolina, on the east side of Easley Bridge Road, about two and one-half ($2\frac{1}{2}$) miles from Greenville Court House, S.C., and beginning on Piedmont Avenue, corner of lot No. 4, and running thence with the line of lot No. 4, N. 80-30 E. 150 feet; thence N. 9-30 W. 88 feet to Easley Bridge Road; thence with Easley Bridge Road S. 70 W. 151 feet to Piedmont Avenue; thence with Piedmont Avenue, S. 9-30 E. 60 feet to beginning corner, being lot No. 2 of Edgemont, a subdivision of land represented by a plat recorded in Plat Book D, page 35, R.M.C.
