TITLE TO REALESTATE

IT IS FURTHER AGREED, that the party of the first part, leases to the party of the Second part, building located on Highway No. 29 near Piedmont, S. C. said building known as Georges place with use of Front property, and extending back of building Thirty feet, for a period of Five (5) years at Eight Dollars, (\$8.00) per month dating from March 1st, 1937, payable at the beginning of each calendar month, during the life of this lease.

IT IS FURTHER AGREED, that the party of the First part will pay all State and County Taxes on said property, and that the party of the Second part will pay for all Licenses, and Taxes on his Stock.

IT IS FURTHER AGREED, That if the party of the Second part should makes any changes or alterations to the present building, it shall be at his expense, and at the expiration of this lease becomes the property of the Party of the First Part.

IT IS FURTHER AGREED, That the party of the First part will furnish party of the Second Part with running water in said building, and in the event of failure of the water supply the party of the First part will have Thirty Days to make sufficent repairs to water lines.

THIS CONTRACT AND LEASE is being made in duplicate, a copy furnished each party, and that it is signed in duplicate, and that any changes in said contract must be made in writing, and that the life of this lease ifs Five years, and extends to March 10th, 1942.
