TITLE TO REALESTATE

Lord, and other consideration hereinafter referred to, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Kenneth S. Lord, all of the following described property, to-wit:

All that lot, piece, or parcel of land situate, lying and being in the City of Greenville, Greenville County, South Carolina, and more particularly described, as follows, to-wit:

Beginning at the Southwest corner of the intersection of the South line of Crescent Avenue with the West line of McDaniel Avenue, and from said point of beginning running thence with the West line of McDaniel Avenue, South 9 degrees 50 minutes West 205.5 feet to an iron pin; thence South 77 degrees 46 minutes West 87.5 feet to an iron pin; thence South 2 degrees 45 minutes East 72 feet to an iron pin; thence South 84 degrees 45 minutes West 17.29 feet to a point; thence North 80 degrees 15 minutes West 21.1 feet to a point in line of lot now owned by Thomas Clement Furman; thence along the line of said Furman, North 3 degrees 55 minutes West 272.2 feet to an iron pin on the South side of Crescent Avenue; thence with said Avenue North 83 degrees 35 minutes East 176.9 feet to the point of beginning.
