The said lessee hereby assumes all responsibility to any and all matters arising out of or in connection with the said business of printing and pub Ashing and also the supply and equipment features, other than for any amounts now due thereon therefor. This contract is hereby declared to be binding upon, and to enure to the benefit of, the respective parties hereto, their respective heirs, executors, facinistrators, successors or assigns.
