TITLE TO REALESTATE

STATE OF SOUTH CAROLINA, COUNTY OF GREENVILLE.

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS R. N. Smith County Treasurer of said Greenville County, did issue his warrants directed to the Delinquent Tax Collector for said County and State by authority of the acts of the General Assembley of South Carolina and the statute laws of said State, against T. Q. Blackwelder and J. Whereas, more than twelve months have elapsed since the date of saidsale, and the defaulting taxpayers, or any other party interested, have failed to redeem said land so sold for taxes;

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS THAT I, M. L. Ashmore Delinquent Tax Collector of and for the County and State aforesaid, in consideration of the premises, and the sum of Thirty one & 06/100 Dollars to me paid by the said grantees, The Forfeited Land Commission have granted, bargained, sold and released, and by these presents do grant, sell, bargain and release unto the said grantees, The Forfeited Land Commission their heirs and assigns:

All that lot, piece or parcel of land in the County of Greenville, State of South Carolina, known as lots numbers 541 and 542 of Plat number 6 of the property of the Tryon Development Company, known as Lake Lanier and made by George Kershaw, C. E., recorded in R. M. C. Office for Greenville County in Plat Book "G", page ____, said lots having a frontage of 47 and 47 feet and a rear width of 70.8 and 78.7 feet and a depth of 130.5 and 130.5 feet on one line and 109.5 and 170.8 feet on the other.

Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

To Have and to hold all and singular the premises hereby granted, with the appurtenances, unto the said Forfeited Land Commission their heirs and assigns, forever, according to the form in force and effect of the Laws and usages of the State of South Carolina in such cases made and provided.
