Received of the Southern Bell Telephone and Telegraph Company, One Dollar in consideration of which we hereby grant unto said Company, its associated and allied companies, their respective successors and assigns, the right, privilege and authority to construct, operate and maintain its lines of telephone and telegraph, and for the general transmission of intelligence, including the necessary underground and aerial cable, conduit, poles, wires and fixtures with the further right to permit the attachment of the wires of any other company, or person, to said poles and fixtures upon and over or under the property which we own near the City of Greenville, County of Greenville and State of South Carolina; said sum is received in full payment of said right.

The above mentioned property being that tract or lots of land known and designated on plat of Estate of D. W. Cochrane and Minnie P. Cochrane, by Dalton and Neves, Engineers, July, 1937, as recorded in office of R. M. C. for Greenville County, in Book I, pages 92 and 93.

The following is a description of the location in which the said lines shall be constructed and maintained:

LOTS FRONTING ON AUGUSTA ROAD Line to be constructed along the East property line of lot number 5 and the West property line of lot number 6 from Augus ta Road to rear property line of said lots, thence along the rear property line of lots fronting on Augusta Road.

LOTS FRONTING ON WEST AUGUSTA PLACE. Line to be constructed along the rear property line of lots fronting on West Augusta Place
