C. for Greenville in Plat Book "E", at page 293, Beginning at the southeast corner of lot No. 6, running thence S. 46.36 E. 21 feet; thence N. 42.30 E. 160.9 feet; thence N. 47.44 W. 21 feet; thence S. 42.30 W. 160.4 feet; said lot has a frontage on the south side of West Washington Street of twenty-one-feet. This is a portion of the property conveyed to Jas. E. Peurifoy, Receiver, by deed of F. G. Mauldin dated March 26, 1927, and recorded in the office of R. M. C. for Greenville County in Deed Book 113, at page 197.
