## TITLE TO REALESTATE

NOW THEREFORE, KNOW ALL MEM BY THESE PRESENTS, That me the undersigned of the State and County aforesaid, the owner--of the property below described, for and in consideration of the premises and of the sum of Fifteen Dollars to me in hand paid by the City of Greenville, S. C. the receipt whereof is hereby acknowledged, do hereby release and discharge the said City of Greenville, its successors and assigns, from all claims for damage of any nature whatsoever by reason of the installation and construction of said second pipe line which is to be laid so that the center line thereof will not be further than 35 feet from the center line of the old pipe line. The compensation hereinbefore named constitutes payment for all privileges and rights hereby granted and for all damages arising from the installation and construction of said second pipe line along and over the lands hereinafter described.

A tract of land situated in Cleveland Township, said County and State, and bounded by lands of Porter Clark on the north; Rachel Howard on the east; by A. G. and or Sunie Burgess on the south and west.

There is no mortgage on the above described tract of land.

TO HAVE AND TO HOLD all and singular the rights and privileges hereby granted and released to the City of Greenville, its successors and assigns forever.

I hereby agree to release and give to the City of Greenville, S. C. actual physical possession of the above described premises not later than the 1st day of December 1938.
