The compensation hereinbefore named constitutes payment for all privileges and rights hereby granted and for all damages arising from the installation and construction of said second pipe line along and over the lands hereinafter described.

A tract of land situated in Cleveland Township, said County and State, and bounded by lands of Saluda Land and Lumber Co., on the north; by A. G. or Sunie Burgess on the east; by South Saluda River on the south and on the west by Clara B. Turner. There is no mortgage on the above described tract of land.

TO HAVE AND TO HOLD all and singular the rights and privileges hereby granted and released to the City of Greenville, its successors and assigns forever.

I hereby agree to release and give to the City of Greenville, S. C. actual physical possession of the above described premises not later than the 5th day of December, 1938.
