TITLE TO REALESTATE

STATE OF GEORGIA COUNTY OF FULTON

KNOW ALL MEN BY THESE PRESENTS, That Southeastern Compress & Warehouse Co., a corporation of said County and State, for and in consideration of the premises, and of the sum of One Hundred Twelve and 30/100 Dollars, to it in hand paid by the City of Greenville, South Carolina, the receipt whereof is hereby acknowledged, do threby grant unto the said City of Greenville, its successors and assigns, the right, privileges and essement to go in and upon that tract of land, situated in Greenville Township, in said County and State, bounded by lands of Poe Mfg. Co. on the North, Southern Rwy. on the East Hampton Ave. Extn. on the south & West To construct and maintain in, upon and through said premises, in a proper manner, pipe lines, air vents, blow off connections manholes and other necessary apparatus incident thereto, using the necessary appliances and machinery for such work for the purpose of conveying water through the premises above described, together with the night at all times to enter upon said premises for the purpose of inspecting said lines and making be essery repairs and alterations thereon, together with the right to cut away and the proper operation of same.

Special Form

It is understood and agreed that the right-of-way to be used under this contract is throughout the above property which is approximately 1123 feet in length, and it is further understood and agreed that the City shall have a right to use a strup of Land fifty feet in width across said premises during the installation of said pupe line. The location of said pipe line is to be approximately along the line as now located and staked out by the engineers.

It is further understood that the owner is to have the same privileges and rights to cultivate and use this right-of way strip of land as he had finer to this agreement, provided, such use thereof will not interfere with the proper maintenance of its line.

It is further agreed that in case of futhre damages to property or crop, due from an accident on said pipe line, that the City of Greenville shall pay all damages.

The payment above specified covers compensation for the easement or right-of-way, and also covers all claims for damages along said right-of-way resulting from construction of the pipe line to be laid.

The undersigned agrees to release and give to the City of Greenville, S. C., actual physical possession of the above described premises not later than the 50th day of Dec. 1938.
