Asberry, and R. R. Grant, as Trustees, Greenville County, in the State aforesaid, in consideration of the sum of *One Thousand Dollars to us in hand paid at and before the sealing of these presents by Springfield Baptist Church, its Trustees, Eddie Cureton, Thomas Hadden, George Parker, Charlie Brooks, and W. B.
