The electric distribution lines and system of the said Judson Mills located in the mill village of Judson Mill No. 2, and heretofore used for serving said mill village and said electric distribution lines and system, being approximately shown on the print hereto attached and made a part hereof, including all poles, wires, transformers, guy wires; cross-arms, insulators and all other property constituting said electric distribution lines and system, except the meters.

AND for the consideration above set out, the said Judson Mills does hereby grant, sell and convey, so far as it is authorized to do so, to the said Duke Power Company, its successors and assigns, the right, privilege and easement over, upon and across the lands, streets and ways in said mill village, of maintaining, operating and using said electric lines and system as same are now located and constructed and such lines as may hereafter be located and constructed by Duke Power Company, its successors and assigns, along the streets or roads shown on plat of Judson Mills No. 2 Village.
