White, individually and as guardian of Edna Mae White Hunter, for and in consideration of the sum of One (\$1.00) Dollar, to me in hand paid, receipt of which is hereby acknowledged, and the premises hereinabove narrated, do hereby grant, bargain, sell and release unto Edna Mae White Hunter all that lot of land with buildings situated thereon, which is located on the southeastern side of the old Townes Road, or Easley Bridge Road, which begins at a point 60-feet from the southwestern intersection of the said Easley Bridge Road and Poplar Avenue, and runs thence S. 45 W. 75 feet along the Easley Bridge Road to the joint corner of Lot #9; thence along joint line between lots numbers 8 and 9 S. 40-2 E. 190 feet to iron pin rear corner of lots numbers 8 and 9, the same being on the edge of an alley; thence N. 45 E. 75 feet to an iron pin joint corner of lots numbers 7 and 8; thence N. 40-2 W. along the joint line of lots numbers 7 and 8 190 feet to the beginning corner; subject, however, to the sidewalk reservations expressed in the deeds involved in the chain of title of this lot, which is lot #8, as shown on the plat of Westview, a Suburb of Greenville, S.
