I, Lawrence Penson, of the afcresaid State and County, being of sound mind, but considering the uncertainty of my eartherly existence, do make, declare and publish this my Last Will and Testament:

ITEM 1. I will and direct that my Executris, hereinafter named, shall give to my body a decent burial, according to the wishes of my friends and relatives, and pay all funeral expenses, together with all my just debts, out of the first moneys which may come into her hands belonging to my estate;

ITEM 2. I will and devise unto my two sons, by my first marriage, John Penson and Jerry Penson, all of my one-third interest in and to that lot of land, and all improvements thereon, situate on the East side of Leach Street, in the City of Greenville, and State of South Carolina, and more particularly described as follows:

All that piece, parcel or lot of land situate, lying and being on the East side of Leach Street, in Ward V. of the City of Greenville, and having the following metes and bounds, to-wit: Beginning at a stake, a corner of lot No. 6. (recently bought by J. F. Mitchell) and running thence along said (street), Leach Street S. 18 W. 62 feet and 6 inches to a stake, corner at alley; thence along said alley S. 72 E. 101 feet to a stake, corner of Susie Paydon's lot; thence along line of Paydon's lot N. 18 E. 62 feet and 6 inches to a stake, corner of lot No. 6; thence along line of No. 6, N. 72 W. 101 feet to the Beginning corner; and known as "Lot No. 7" on Plat made by J.
