1. That on or about February 28th, 1930, Smith Wood, the father of petitioner, executed his certain deed whereby he conveyed unto Miles Wood as Trustee for your petitioner the following described real property:

That certain lot of land, with improvementd thereon, in Chick Springs Township, said County and State, and on the north side of the (formerly) National Highway, and Beginning at a stake in the center of the said National Highway, W. W. Burgiss' corner, and runs thence N. 39-45 W. 214 feet to a stake; thence N. 35-0 E. 754 feet to a stake on Burgiss' line; thence S. 56-45 E. (about) 240 feet to a stake on Burgiss' corner; thence with this line S. 35-0 W. 820 feet to the beginning corner, and being lot No. 1 as appears upon a plat made by H. G. Bailey, and containing three and 92/100 acres, more or less, and being the same conveyed to the said Smith Wood by Mrs. A. E. Caldwell by deed recorded in Vol. 177, page 101.

- That the said Trustee, Miles Wood, has expressed a desire to renounce said trust and be discharged therefrom, and that some one else be so appointed under said deed, with all the powers, trusts, responsibility and privileges as stated therein; and your petitioner as the cestui que trust named therein, now agrees to and joins in the request that a substituted trustee be appointed, and that the said Miles Wood be discharged therefrom, freed and released of and from all responsibility or accountibility of any nature or to any degree on any matters connected with said trust estate, whether the same be any heretofore contracted or incurred or now in the course thereof.
