C. Wood, deceased, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said R. B. Wood, his heirs and assigns forever:

That certain tract or parcel of land in O'Neal Township, and Washington School District, said County and State, containing forty (40) acres, more or less, and more particularly shown by a plat to be made by H. S. Brockman, Surveyor, and having the following metes and bounds, to-wit:

Beginning at an iron pin on line of G. L. Brown, and running thence S. 84-11 E. sixteen hundred eighty-three (1683) feet to iron pin on line of Enoch Howell; thence with Howell's line, N. 4-00 E. one thousand fifty-six (1056) feet to W.
