RENEWAL.

Fifteenth: Provided written notice is given Lessor not less than six months prior to the expiration of the term of five years herein granted, and provided the Lessor does not need the premises or any portion thereof for railroad purposes, the Lessee may at its option renew this lease for an additional term of five years at such stipulated rental as may be agreed upon in writing by the parties hereto. Should the said parties on or before the expiration of the present term fail to agree upon the amount of rental for such additional term, then this provision is to be void and of no effect.

This indenture cancels and supersedes contract of date June 3, 1935, between the Lessor and Lessee herein, covering lease of said warehouse No. 1; as well as supplemental letter agreement between said Lessor and Lessee dated May 7-9, 1936, covering lease of second floor of said warehouse No. 2; and supplemental letter agreement between said Lessor and Lessee dated September 3-5, 1936, covering lease of first floor of said warehouse No. 2.
